- Pete stated that Wednesday was a presentation to North Catty and Catty, he was unable to attend.
  - Overall recommendation, not a merger, regionalization
  - o Points in the report -4 levels of cooperation
  - Two departments operate out of Catasauqua.
  - o Still have our own personnel
  - Operating out of there since May 2022 interesting, response time for departments has been cut by almost 2 minutes.
  - o Improved service cooperation to that extent

- Mayor stated the report was very well written, very well done, talked to Roger last Friday.
- Mark asked if our trucks will remain in Catty, all 3 apparatus in Catty Roger said yes, the main out of there, all personnel qualified on all trucks for both departments.
- Mike does that mean that nothing will run out of our borough hall Roger, yes.

- Roger gave Atty. Panella the sample ordinance.

Roger also mentioned there is a \$1k Whitehall Area Chamber of Commerce – we put in for that grant.
